**VEHICLES:** Issuance of a Birch Pointe branded and numbered hang tag at a rate of one tag per unit. Visitors and unit-owned secondary vehicles should be parked only in unmarked spots BP Parking Policy

**PETS:** Owners are permitted to have 2 (two) pets only (no exotic animals). Renters are NOT permitted to have pets/animals while residing in Birch Pointe.
